PRIZING

It is not mandatory to award prizes.

If you award prizes, you should advertise them to attract participants to your event.

If you advertise prizes, you must award them.

If you award prizes, you must respect Velo NB's prize equity policy (below).

Prize Equity

The top placed woman rider of the day is to receive the same prize amount as the first place rider in the A category, regardless of the category she rides in, unless she is in fact the winner of the A category race and is the recipient of that race prize.

If riders in other categories receive prizes, the top placed women in those categories must receive the same prizes as the top placed men.

If the top placed female rider of the day is also entitled to a prize within her category, she must elect whether to receive the female prize or the category prize. The prize she doesn't choose goes to the next placed rider, and so on.

Organizers should pay deeper into the women's field if participation numbers merit it. Female participants must receive, at minimum, prizing in proportion to their participation.

Note that these are minimum requirements, designed to ensure that female competitors receive equal prizing based on participation. By all means, feel free to do better. Even if you do not award cash, why not recognize equal numbers of men and women with medals, trophies, etc.
